Preamble:

Rajeev Gandhi University of Health Sciences in their letter cited at (1) above has recommended to the Government for affiliation the application submitted by the Zulekha College of Nursing, Kodialbail, Mangalore-575 003, under Section 45 (2) of Rajeev Gandhi University of Health Sciences notification, 1994, for increasing the admission limit of B.Sc. Nursing Course from 30 to 60 seats from the year 2010-11 onwards, along with the report of the Local Inspection Committee, Academic Council and Syndicate Council reports:

The Director of Medical Education in his letter cited at (2) above has recommended to the Government to pass a Government Order, stating that the Zulekha College of Nursing, Mangalore has all the required basic infrastructure facilities for increasing the admission limit of Basic B.Sc. Nursing Course from 30 to 60 seats from the year 2010-2011.

After examining the matter in detail with the relevant records, Government decided to increase the annual admission limit to B.Sc. Nursing Course at Zulekha College of Nursing, Kodialbail, Mangalore – 575 003 from the year 2010-11, the following order is passed:



Government Order No. AAKUKA 400 MPS : 2010, Bangalore dated 14.12.2010

In exercise of the powers conferred u/s 45(5) of Rajeev Gandhi University of Health Sciences Act, the Government recommends the increase of admissions limit to B.Sc. Nursing Course from 30 (Thirty) to 60 (Sixty) seats at Zulekha College of Nursing, Kodialbail, Mangalore-575 003, from the year 2010-11 subject to the following terms and conditions:

TERMS AND CONDITIONS:

- Zulekha College of Nursing, Kodialbail, Mangalore-575 003 shall leave 20% of the seats in B.Sc. Nursing Course to Government for allotment.
- The approval of the Rajeev Gandhi University of Health Sciences shall be obtained for the increase of seats of the above Nursing Course.
- Approval under Section 13 of Indian Nursing Council Act from the Nursing Council of India shall be obtained and the Rules and Regulations fixed by the Nursing Council of India shall be strictly followed.
- 4. The admission of students specified shall be made only after obtaining the approval u/s 13 of the Indian Nursing Council Act, from the Nursing Council of India. Admission of excess students shall not be made from any reason. In case of violation of this, criminal action will be launched as per Karnataka Prevention of Admission of Students to Unrecognized and Unaffiliated Education Institutions Act, 1991.



- The instructions and orders given by the Nursing Council of India, Karnataka State Nursing Council and the State Government from time to time shall be followed.
- As per the guidelines of the Nursing Council of India, own hospital facility shall be had within 5 years, failing which the affiliation will be withdrawn.
- The admission to students shall be made as per Karnataka Nursing, Pharmacy and Physiotherapy Course candidates admission Selection Rules 2003 and the specific ratio of Government Quota and Management Quota as fixed by the Government for MSC, Nursing, MPT and M. Pharma Courses from time to time.
- The above college will not be given any subsidy, financial assistance from the Government of Karnataka. This is subject to the conditions of being permanent unaided college.
- The affiliation will be withdrawn u/s 48 of the Rajeev Gandhi University of Health Sciences Act, 1994, in case of violation of any of the above terms and conditions.

PREAMBLE :

While submitting the application by the Julekha Nursing College, Kodialbail, Mangalore 575 003 to start new courses in (1) M.Sc.in Medical, Surgical Nursing, (2) M.Sc. In Community Health Nursing, (3) M.Sc. in O.B.G. In exercise of the powers conferred vide Section 45(5) of Rajiv Gandhi University of Health Sciences Act 1994, the Government has recommended for according affiliation to start new courses in (1) M.Sc. in Medical Surgical Nursing, (2) M.Sc. in Community Health Nursing, (3) M.Sc., in O.B.G. Nursing, (4) M.Sc. in Paediatric Nursing and (5) M.Sc. in Psychiatry Nursing Courses from the year 2012-13, with annual admissions limit of 4 (four) seats at Julekha College of Nursing, Kodialbail, Mangalore subject to the following terms and conditions:

TERMS AND CONDITIONS

- (1) Julekha College of Nursing, Kodialbail, Mangalore 575003 shall give up 25% of the seats in the above M.Sc. Courses for Government allotment.
- (2) The sanction shall be obtained for the commence of the above courses from the Rajiv Gandhi University of Health Sciences.
- (3) Approval from the Nursing Council of India as per Section 13 of the Indian Nursing Council Act, 1947 shall be obtained and shall strictly follow the terms and conditions fixed by the Nursing Council of India, shall possess the basic facilities as fixed by the Rajiv Gandhi University of Health Sciences, Karnataka State Nursing Council and Nursing Council of India.
- (4) Admission to the students shall be given only after obtaining approval of the Nursing Council of India as per Sec. 13 of the Indian Nursing Council Act 1947. Admission shall not be given

to additional students for any reasons. If any violation is noticed criminative proceedings will filed as per Karnataka Prohibition of Students to Unrecognized and Un-Affiliated Education Institutions Act, 1991.

- (5) The suggestions and orders given from time to time from the Rajiv Gandhi University of Health Sciences, Nursing Council of India, Karnataka State Nursing Council and the State Government shall be compulsorily followed.
- (6) Own hospital facility as per the guidelines of the Nursing Council of India shall be obtained within a period of 05 years, failing which, the affiliation will be withdrawn.
- (7) Admission of students shall be done only according to the Karnataka Nursing, Pharmacy, Physiotherapy Courses, Admission Rules 2003, and the directions of the Government for the Government Quota and management quota regulated for the admissions to M.Sc. Nursing Course from time to time.
- (8) The Government of Karnataka will not give any type of grant or financial facility to start the above institution.

(9) In case of violation by the above institution of any of the above conditions, the affiliation given to the above Institution will be withdrawn as per Section 48 of the Rajiv Gandhi University of Health Sciences Act, 1994.
